Dr Alkis (Alkiviadis) Gounaris is a post-doctoral researcher at the National and Kapodistrian University of Athens and has been teaching for several years in the Postgraduate Programmes of the Department of Philosophy, School of Philosophy, as well as in Lifelong Learning Programmes of NKUA and other institutions. His fields of expertise include the philosophy of human cognition and artificial intelligence, epistemology, and applied ethics.

He holds two Bachelor's Degrees, one in Sports Sciences and one in Philosophy, a Master's Degree in Ethics and a PhD in the Philosophy of Mind, all four from the National and Kapodistrian University of Athens.

From 2020 to 2023, he worked as a researcher and coordinator of the Sophia at School project, which introduced philosophy into primary education. In 2025, he completed his postdoctoral research on The Role of Philosophy in Interdisciplinary Research and the use of Artificial Intelligence tools to address epistemological and meaning-related challenges. He is a research fellow at the NKUA Applied Philosophy Research Laboratory and a senior research member of the PPE Lab at the National and Kapodistrian University of Athens. He also serves as a member of the Expert Group on Artificial Intelligence of the National Commission on Bioethics and Technoethics, while teaching as adjunct faculty at the Open University of Cyprus.

He has authored over fifty publications and conference papers in Greek and international journals, and has organised over 150 public events dedicated to disseminating philosophy to broader audiences.
